Financial Review

Did not include the cash balance report, will email later. Will meet with county to get all my cash balances rolled over. We instituted the raise for the minimum wage with classified staff, there was a hiccup with the implementation with employees on spread pay. We did an audit of all classified employees, we checked wages and pay, verified. We put together reports and met with every employee that was affected, explained to them the reason the change. Discussion.

**Alternative is to not have spread pay.

**The challenge was the second semester they are working 2 weeks less than the first semester. It would have helped if we showed them a daily rate. Our options are maybe to start in January with what we think the increase would be.

Report that says "Heber Overgaard School District" finished with first part of our Performance Audit. We have another audit, Emergency Response Practices. I also have a food service audit coming up in March. We have had an issue last year that has rolled into this year with the transition in paying for lunches & breakfasts and having them free. A lot of the parents were used to the free and then to say that it is done, a lot

from last year had accumulated and rolled into this year. The admin has decided with your blessing that we would like to write off their balances \$3,711.58. I will be notifying all the parents that they will not be able to charge more than \$40. If they do not pay, they will be served a peanut butter and jell sandwich/sack lunch instead of a hot lunch. Discussion.

Superintendent Report

Mr. Tenney-Spelling Bee went well, end of year concerts went well. Staff helped with the concerts, was greatly appreciated. Another training coming up this Friday from Capturing Kids Hearts. I did speak with Carmen, the DLR Group is just the cost, I asked her to simplifying the gym and taking out classrooms we talked about, seeing what kind of savings we can get. She estimates around a 1.8 million savings by shrinking it down. We will have an A and a B to look at. We will have other things in the proposal for the other schools that need to be done. The Trust Model Policy program. You can go through that, I recommend that we go with the Trust and move away from ASBA. The fees \$255 for set up (onetime fee), annually \$240, comprehensive policy review \$1,000 which I suggest we do. If we go this route I suggest we put it on March's agenda and then start the process. Plaque from ASBA – recognized for total board boardsmanship award.

Governing Board

It is going to change a little bit. I looked up the median home sold price \$269.00. The last time we had a new money issue was 2009.

Instructional Time Model Approval

ITM is the program that schools use to submit to the state as an online or remote learning for students. You don't have to spend as much time online as you would in class they would have some activities to do online. The biggest challenge that I have talked to with other schools is what to do with classified staff. I have provided some ways that they can get paid with trainings, if they want to work remotely or come in. They could also use Comp/personal time if wanted. This gives us a little leeway to provide a continual education for kids despite the weather. I sent out a survey to parents, I was surprised how many said they do not have access to internet, at that time there was only 2 parents that said they had no internet. We posted the survey on the website as well. We had about 80 responses. Most of the parents are in favor of coming up with something for the kids online. We would probably stagger the schools times for the students to be online.

Ms. Hall made a motion to approve the Instructional Time Model as presented and Mrs. Weber seconded the motion. The motion was passed unanimously.
