Proposed 301 Plan FY2223

Teacher-We met as a committee again, we go through and look at the different items that may need updated or changed. The change we are proposing is on item #7, that the teachers will have to have their grades updated in the system by 8:45am on a Monday of grade check weeks and that teachers will provide students access to their grades every 2 weeks. I do want to talk about #6, professional development. Discussion about absences on professional development days. Over the past couple of years teachers have been concerned about if they do not attend PD then they have to use 7.5 hours of leave and also docked on their 301 monies. We did say as the committee here is the concern. Discussion on what reasons teachers are missing PD days. We bring it up as a committee with a concern but we didn't change anything. Discussion.

Ms. Hall made a motion to approve the proposed 301 Plan FY2223 as presented and Mrs. Weber seconded the motion. The motion was passed unanimously.

Revised Classified & Extra Duty Salary Schedule FY2223

Minimum Wage Increase

I went ahead and put the actual official posting from the Federal Government, hopefully it made since the way I put the revisions on the paper. All the tally marks are all the people it will affect. In meetings with other districts, they are struggling with entry level positions and people that have been there forever.

Mr. Tenney - we took out column 3 and moved it over to column 5. Column 2 is the new Colum 1 to coincide with the new minimum wage. We went from 8 columns down to 7.

Ms. Hall made a motion to approve the Revised Classified & Extra Duty Salary Schedule FY2223 effective December 29, 2022 as presented and Mrs. King seconded the motion. The motion was passed unanimously.

Forest Fee Salary Schedule RevisionFY2223

This is a revised Forest Fees payout for December, you had approved one earlier back in June I believe. This shows what FY2122 was and what FY2223 will be. It will be in the neighborhood of \$25,000 total with benefits for those payouts.

Mrs. Despain - We moved our secretaries to the 12 month position because of all they did this summer. We feel like we needed to give a director a payout as well. There is a total dollar amount on the paper. We're trying to move everything out of forest fees and put everything into M&O because we don't know when Forest Fees is going to go away.

BM - Can we use it for capital?

Mrs. Despain - Yes.

Mrs. Weber made a motion to approve the Forest Fee Salary Schedule Revision FY2223 as presented and Mrs. King seconded the motion. The motion was passed unanimously.

Policy Advisory 737-738 Volume 34 #3 Final Viewing & Adoption

Most of this is immunizations, pg. 111 is that schools cannot require to COVID 19 or any variant. Parents can sign a waiver to opt out. If students are homeless they can be waved. We probably still have a few students that need to turn in their waivers. It does give the schools the right to have students not attend if they do not provide immunization records unless there is a written note from a parent or doctor, then they can sign the form. If there is an outbreak talks about what we need to do to report it. Freedom of information. We can charge for a copy if we get a public records request.
